3. The Company repurchased 52,016,000 H shares in May 2020. All such repurchased H shares were subsequently cancelled. As approved by the PRC corporate registration agency and the extraordinary general meeting of the Company convened on 30 September 2020, the number of the H Shares of the Company was reduced from 1,952,016,000 to 1,900,000,000, the total number of the issued ordinary

shares of the Company was reduced from 4,912,016,000 to 4,860,000,000, and registered capital of the Company was reduced from RMB4,912,016,000 to RMB4,860,000,000.
